This consent to the processing of Personal Data is valid for 3 (three) years from the date of its signing and can be revoked by me at any time by submitting a simple written request to the Operator.

The subject's Personal data are subject to storage within the time limits established by the legislation of the Russian Federation. Personal data is destroyed: upon reaching the purposes of personal data processing; upon liquidation or reorganisation of the Operator; upon of a written request from the personal data subject to terminate the processing of their personal data (the Operator will stop processing such personal data within 3 (three) working days, of which a notice will be sent to the personal data subject within 10 (ten) working days).
